1. Organiser and scope

Klymyuk, ART of, Pfingstweidstrasse 31, 8005 Zurich, Switzerland, CHE-396.840.801, organises Stage de Danse Marseille 2027. The written admission offer and edition-specific information form part of the agreement.

2. Programme and educational character

The programme is intensive dance education. Exact faculty, repertoire, studios, class order, daily schedule and group allocation may vary by edition.

3. Eligibility and minimum age

The standard programme is open from age 12+, subject to level, training background and capacity. Professional Dancer and Observation applicants may be asked for evidence.

4. Application

Applications must be complete and accurate. Submitted photographs, videos and documents must be lawful to provide. Submission does not create a right to admission.

5. Application fee

The application fee is EUR 40 plus separately disclosed third-party charges. It is separate from tuition and is non-refundable once assessment has begun, except where mandatory law requires otherwise.

6. Assessment and admission

ART of assesses applications individually. Admission is valid only when confirmed in writing.

7. Course fee, payment and place

Tuition and payment deadline are stated in the written offer. Unless otherwise stated, tuition is due within 14 days. Instalments require written agreement.

8. Attendance and programme pathway

Participant profile and attendance are separate matters. Full-course, week, one-day or Single Class access exists only as expressly confirmed; particular classes remain subject to level, placement, schedule and capacity.

9. Professional Dancer participation

Professional status/rates apply only when eligibility is met and expressly confirmed. ART of may request evidence and may offer standard tuition where a special rate does not apply.

10. Observation

Observation is professional development for eligible professionals. Observers may not intervene, record classes, reproduce teaching material or access confidential participant information.

11. Artistic, professional and audition opportunities

Additional artistic, audition, coaching, networking or educational opportunities may be offered selectively. Admission does not guarantee school/company admission, employment, scholarship or contract.

12. Faculty, repertoire and programme changes

Faculty, pianists, repertoire, studios, group allocation and timetable may change for artistic, operational, health, safety, contractual or availability reasons.

13. Participant withdrawal and cancellation

Unless the written offer is more favourable and subject to mandatory law: cancellation at least 3 months before = 50% tuition charge; less than 3 months but at least 1 month = 70%; less than 1 month = 100%. Application fee is separate.

14. Illness, injury and missed participation

Illness, injury, travel disruption, visa/entry problems, late arrival, early departure or voluntary absence do not normally create a refund or replacement-class right. Medical cases may be reviewed individually.

15. Cancellation or material change by ART of

If ART of cancels the entire intensive without a reasonable replacement/reschedule, tuition for the cancelled programme is handled under applicable law. Partial changes may be reasonably replaced or adapted.

16. Events beyond reasonable control

ART of may adapt, postpone, relocate, shorten or cancel affected elements when circumstances outside its reasonable control materially prevent or restrict performance.

17. Health and physical demands

Intensive dance training is physically demanding and carries inherent injury risk. Participants must provide relevant health/safety information and follow faculty and venue instructions.

18. Insurance
